




Key Revenue Items







Monthly Commentary

Delaware's labor force continued its trend downward in April to 506,300, a sixth consecutive month of declines, but remained higher than a year ago. The seasonally adjusted labor force participation rate of 60.1 percent is the lowest since April 2020 when the rate was 59.5 percent, the lowest point since record-keeping began in 1976. April's seasonally adjusted unemployment rate of 3.9 percent marks the first time Delaware's rate has equaled the US unemployment rate since January 2020. Delaware's unemployment rate has remained higher than the US rate for thirty-three consecutive months, since June 2021, when Delaware's rate was 5.8 percent and the US rate was 5.9 percent.

Delaware Labor Force Trends

Delaware's seasonally adjusted unemployment rate in April 2024 was 3.9%, unchanged from March 2024. There were 19,800 unemployed Delawareans in April 2024 compared to 19,300 in April 2023. The US unemployment rate was 3.9% in April 2024, up from 3.8% in March 2024. In April 2023, the US unemployment rate was 3.4%, while Delaware rate was 3.8%.

In April 2024, seasonally adjusted nonfarm employment was 490,400, up from 488,300 in March 2024. Since April 2023, Delaware's total nonfarm jobs have increased by a net gain of 7,200, a rise of 1.5%. Nationally, jobs during that period increased by 1.8%.


