





# **Monthly Commentary**

Delaware's total private sector average hourly wages grew to \$31.57 in October, an over-theyear (OTY) hourly increase of \$0.32 or 1.0 percent, the slowest pace of OTY wage growth since April. Workers in Delaware's largest employment industry, the Trade, Transportation, and Utilities supersector, had the greatest average hourly wage increase from a year ago, growing to \$25.88, an increase of \$1.48 or 6.1 percent. The Manufacturing and Leisure and Hospitality sectors had the second and third-largest over-the-year average hourly wage increases, rising by 3.1 percent and 2.1 percent to \$34.20 and \$19.64, respectively. Financial Activities workers had the highest average hourly wage at \$37.88 but saw the largest over-the-year decline of \$0.64 or 1.7%.

# **Delaware Labor Force Trends**

Delaware's seasonally adjusted unemployment rate in October 2024 was 4.0%, down from 4.2% in September 2024. There were 20,200 unemployed Delawareans in October 2024 compared to 20,900 in October 2023. The US unemployment rate was 4.1% in October 2024, unchanged from September 2024. In October 2023, the US unemployment rate was 3.8%, while Delaware's rate was 4.1%.

In October 2024, seasonally adjusted nonfarm employment was 488,000, down from 489,400 in September 2024. Since October 2023, Delaware's total nonfarm jobs have increased by a net gain of 2,600, a rise of 0.5%. Nationally, jobs during that period increased by 1.3%.


