

# **Monthly Commentary**

In 2024, Delaware's revised seasonally adjusted annual unemployment rate of 3.7% tied with two other states (Idaho and Missouri) for the 28th lowest in the nation. It was 0.3 percentage points lower than the US annual average rate of 4.0 percent. Annual benchmarking lowered Delaware's annual average number of unemployed from an original estimate of 20,200 to a revised estimate of 18,700, a decline of 1,500 workers. In February, the Labor Force Participation rate set a record low at 59.0 percent. The number of residents in Delaware's labor force fell by 300 to 506,500, its lowest level since April 2023 when 505,700 residents were working or looking for work.

# **Delaware Labor Force Trends**

Delaware's seasonally adjusted unemployment rate in February 2025 was 3.6%, unchanged from January 2025. There were 18,500 unemployed Delawareans in February 2025 compared to 18,900 in February 2024. The US unemployment rate was 4.1% in February 2025, up from 4.0% in January 2025. In February 2024, the US unemployment rate was 3.9%, while Delaware's rate was 3.7%.

In February 2025, seasonally adjusted nonfarm employment was 493,400, up from 491,200 in January 2025. Since February 2024, Delaware's total nonfarm jobs have increased by a net gain of 6,400, a rise of 1.3%. Nationally, jobs during that period increased by 1.3%.


